Swedish banks lack policies against killer-robots - demand change!

The largest banks in Sweden lack policies against killer robots, autonomous weapons, being weapons that can select and attack targets on their own. Amnesty wants to change this!

Fair Finance Guide is an international initiative which investigates which demands for sustainability and social responsibility banks make. In Sweden, the seven largest banks, along with two smaller, are looked into annually. Through Fair Finance Guide's website, one can easily compare the banks' results and choose to send messages to one's bank directly through the website.

Amnesty in Sweden is one of the organisations supporting Fair Finance Guide's work. This year, we have chosen to bring forth one of the topics which are brought forth in the report. The report states that Sweden's largest banks have chosen to not support the demand of the adoption of a policy regarding killer-robots.

A debate article published earlier this fall by Amnesty, together with three other organizations, highlight some of the greatest risks to human rights that exist when companies are enabled to produce and export killer robots. Among other things, the basic principles of human dignity and the right to life are put at risk if machines are allowed to make decisions about life and death.

On December 2, Fair Finance Guide will release its policy review report for 2020. After the report is released, you will be able to write letters to your banks and demand that they introduce a policy on killer robots. This can be easily done at www.fairfinanceguide.se, where you can already find out more about your particular bank.
