## Take action for the protesters in Thailand!

The violence in Thailand has increased since October. 220 individuals, including 6 children, are facing punishment for participating in demonstrations. Among these are high school students Benjamaporn 'Ploy' Nivac, Free Youth and student union leader Panusaya 'Rung' Sittijirawattanakul; pro-democracy activist Tattep 'Ford' Ruangprapaikitseree, and legal expert and former prisoner of conscience Jatupat 'Pai' Boonpattararaksa.

We call on the Prime Minister of Thailand to immediately and unconditionally drop all criminal proceedings against them, and all other protesters, and that all other attempts to silence critical voices stop immediately. You can take action through letter writing or social media.

# The Activism Strategy - what's in the pipeline?

Last autumn Amnesty Sweden adopted an Activism Strategy which guides us in building our movement in the best possible manner. So what have we done so far?

- Much effort has been put into mapping our activism to learn how we may improve our work in facilitating activists organisation.
- A new CRM system has been developed
- A new form of engagement has been created. We call it "Network". As a member of a
  Network you're subscribed to a newsletter in which you are offered to take action in a
  specific human rights issue. Active networks today are Women's Rights, LGBTI and
  Urgent Actions.
- Another form of engagement is our local organization commissions activists who are taking lead in recruitments and campaigns.
- A first step in working more efficiently with active participation was taken during the development of the operational plans for 2021.

These were a few examples of what we have done so far. Now we're taking new steps towards our goals for 2027!
