THE ELECTORAL PLATFORM – A FOLLOW UP

During the election campaign, we chose to focus on four areas where we see that there are clear deficiencies in terms of protection for human rights in Sweden: justice and care for survivors of sexual violence, Sami rights and climate justice, social justice and social security, as well as the right to housing. We wooed all party leaders and asked them to sign our shortest ever petition (which six out of nine also did) and also urged the Swedish population to make clear demands on Sweden's incoming prime minister to protect and respect human rights. Almost 34000 people signed!

WRITE FOR WRIGHTS – THE EFFECT OF A POWERFUL CAMPAGIN!

21,000 Swedes have signed to the Bengali climate activist Shahnewaz Chowdhury shall acquitted of the cyber crime charges because he warned of the consequences of a local coal-fired power plant in its district. A charge for which he risks ten years in prison alone to have exercised their freedom of expression. The family members of 80-year-old Zineb Radhouane who died when a tear gas grenade from French riot police was fired against her window in Marseilles continues its struggle to their loved ones will receive redress. So far, almost 7000 digital signatures received to demand investigation and that those responsible are held accountable.

Almost 8,000 people have signed the digital list of names to support the Russian artist and musician Aleksandra 'Sasha' Skochilenko who faces ten years in prison for an action where she replaced sticky notes in the vegetable counter against information about Russia's war in Ukraine, which led to prosecution for "disseminating knowingly false information about the Russian Armed Forces". For the Cuban artist and activist Luis Manuel Otero Alcántara has almost 18,000 signatures defense of his struggle for freedom of expression in Cuba. Luis too Manuel's crime is related to him using his freedom of speech in social media and he too risks five years in prison.

Write for Freedom runs throughout the month of January. Then comes the letter harvest of postcards, letters of solidarity and pressure letters to be added to all digital signatures.

BEFORE END OF PROMOTION CAMPAIGN

The deadline for submitting promotional materials to us is 15 January for those of you who acted during November/December. For those of you who want to continue acting, there is an opportunity to do so during January and then you need to send the material like that that they are with the 28th of February at the latest.



THIS IS HOW YOU SEND THE MATERIAL!

- Collect all signed postcards + count the number of the signatures on petition lists and postcards for each individual case and report this.
- Sort the postcards so that the cases are separated from each other.
- Put the petition lists in an envelope and write name of the case on the outside.
- Send all materials to Amnesty headquarters. It is important that the sender is clearly stated!
