## **ACT FOR ABORTION RIGHTS IN THE FAROE ISLANDS!**

In the North Atlantic lie the Faroe Islands, a self-governing country within the Kingdom of Denmark. The archipelago has 50,000 inhabitants - and one of Europe's most restrictive abortion laws. The Faroe Islands are the only country in the Nordics where women do not have the opportunity to choose abortion themselves. The important fight for abortion rights continues and will continue as long as states restrict the important right of women, girls and others who can become pregnant to their own bodies! Now we put in a gear to decriminalize abortion in the Faroe Islands!

Together with other activists and sections, we are collecting signatures to show solidarity with the women in the Faroe Islands and to show that there are many of us who think that everyone who can become pregnant should have their basic right to decide over their body and pregnancy. The signatures will be handed over to Minister of Social Affairs Sólvit E. Nolsø, who is responsible for abortion legislation in the Faroe Islands. The future abortion legislation in the Faroe Islands must guarantee that people can access abortion in a safe and secure environment with respect for their wishes, needs and rights. Demand that girls, women and others who may become pregnant have the right to decide over their own bodies!

Send the signatures by November 30 to the secretariat. The signatures will be submitted to the Minister of Social Affairs on December 10! More information about where you send the signatures and materials can be found on the Activist portal.

### **Amnesty Foundation's board**

The Amnesty Fund provides assistance to human rights defenders and support to, among other things, organizations that document violations of human rights. The Amnesty Foundation's board is responsible for the fund's finances and that the activities are carried out in accordance with the fund's statutes and other governing documents.

The selection committee is looking for people for the Amnesty Fund's board with expertise in, among other things, human rights and international law, law, leadership, financial management, communication and equality.

This year, we are looking for four regular members and three deputies for the fund board.

### The Review Committee

The review committee's mission is to review the section's work, administration and decisions, which requires a good ability to evaluate goals and results from an overall perspective.

This year we are looking for a member and a deputy for the review committee. The preparation committee works to receive proposals from members and support members in formulating motions for the annual meeting.
