Time for Change - review how you local newspaper reports on rape!

The campaign Time for change is based on the nordic report with the same name. The report provides three recommendations on how to improve the work against rape in Sweden; the need to change attitudes, that the investigations made by the police improves, and that all who are exposed to rape shall receive the support and care that they need, regardless of whom they are and live.

During the spring and summer months we have we have encouraged the police to prioritize sexual crimes and rape as well as improve the quality of police investigations. Our work has proven successful and the national police management notified that a special investment shall commence which includes 350 newly hired investigators and these are distributed nationally. Additionally, 350 million SEK are invested. YAY! We will monitor this to see what the results will be.

Next step

The next step will be to observe stereotypes and attitudes on rape. Media is an important actor in this, media can fortify and reproduce harmful, stereotypical notions of rape. But, in the long term they can also change the same attitudes through responsible reporting about rape. This is the reason for why we are going to initiate a dialog with local media on how reporting on rape could be improved.

To initiate a dialog with media we need to examine how the current situation is. This is where you come in to monitor your local newspapers! The first step is to investigate how the newspaper reports on rape, there is a cheat sheet to assist you in this and a question form to use.

The next step is to contact the newspaper to discuss your results.

Work with individual cases!

When working with individual cases you normally focus on one or multiple cases during a longer period of time. However, you can also work with individual cases with the network Amnesty Alert, through web-actions, or other actions that require a fast coordination of activism.

The work with individual cases is very important and the work Amnesty does often have an impact on the people we are working for. However, it can be difficult to keep engaged around a case that might not see any progress since a big portion of the people we are working for recieve long prison sentences.

During the fall, multiple cases have been closed due to release from prison, for example; Liu Ping, Dong Guangping, Su Changlan from china, Mahmoud "Shawkan" Abou Zeid from Egypt and Oleg Sentsov from Russia.

In Sweden, the Roma and other vulnerable EU-citizens live in an acute rights situation where, according to the report "Sweden: A Cold Welcome", it is presented that these persons lack the right to basic needs such as housing, water, and sanitary rights including health care. Additionally, a recurring issue in Stockholm is harassment from the police.

This situation is unacceptable where the demands from Amnesty is that the Swedish state and responsible authorities take their responsibilities for vulnerable EU-citizens in Sweden. I am a part of group 172 in Stockholm, and we work with the campaign for vulnerable EU-citizens though various methods and actions.

Hong Kong

We have documented grave human rights violations during the peaceful protests in Hong Kong for the last few months which, by China, has been justified through a question of "National security and sovereignty".

We demand that Hong Kong immediately and independently initiate investigations into the violence towards protestors. What you can do:

 or whatever you like and share it on social media with the hashtag #staystronghongkong

South Korea

The report "Serving in Silence" that Amnesty released in July shows discrimination of homosexual men in the south korean army. Sexual acts between in the military can result in a two years prison sentence and in 2017, more than 20 men in the military where sentenced for suspicion of homosexual sex.

We demand that the defense minister initiate a change of the law in that affects homsexual men in the military and that the parliament adopts anti-discrimination laws that forbid discrimination on various grounds, including sexuality and gender identity. What you can do:

- Do petitions to collect signatures for the law to be abolished. The petitions-lists, and a poster, are available for printing on **aktivism.amnesty.se/hbtqi**. The signatures will be handed over to relevant authorities by Amnesty in South Korea.

The board informs

During the meetings this fall we have discussed and decided on two important strategies, that the annual meeting in 2020 will be held in Stockholm, and adopted budgetary frames for 2020.

The equality strategy

The strategy is based on the long term direction, that was decided on the annual meeting of 2016, where all the work of Amnesty should have an atmosphere of inclusion and accessibility. According to the equality strategy, all of the work towards greater equality should be characterized by responsibility, courage, and dedication. The goal is to increase knowledge and change behaviours. This work has been initiated on the secretariat, but has also been discussed on the mega weekend and will be emphasized during the next annual meeting and on other member-meetings as well for the greatest effect and spread.

Activism strategy

This strategy is about activism and how to organise to create opinion about the questions that Amnesty works with, and achieve change. In the long term direction, it is stated that activism should be based on trust, participation, and joint responsibility. Our aim should be to develop and obtain better relations between members, develop the local organisation, greater impact from our members and develop engagement in our areas of expertise.

The equality strategy and the activism strategy will be developed and thereafter made available for all members.

Budget 2020

During the fall, another central question has been the operational priorities of the secretariat and the budgetary frames for 2020. The board experiences a need in continuing the work with development projects that will result in larger participation in the work of Amnesty and increase the effect of our lobbying work. During 2020, it is expected that the ongoing donations, recruitment of new members/donors and other funding will generate 140 million SEK to the organisation, where 38 million SEK will be donated to the international section. The final decision regarding the budget will be made at the board meeting in december.

Strategic goals

Next summer it is time for the international section to make decisions about new strategic goals for Amnesty International. Prior to this, it is now discussed how the global changes happening currently will affect the direction of which questions Amnesty will prioritize. When the agreement on areas of prioritization has been made, the swedish section will decide which type of work we will pursue in order to achieve the joint goals. For the swedish section to be able to adapt our prioritising towards the goals of the international organisation, but also have the time for proper consultation with the members of the section, our new strategic period will commence in 2022.

Annual meeting

The board has evaluated the annual meeting of 2019 and the investments made during the last two years, for example on how to combine the annual meeting with campaign trainings and a HR-seminar but also that the section has funded all costs for trips, accommodation, and food. For the annual meeting in 2020 the board has decided to focus more on management questions, for example elections for the 'confidence body' of the organisations, and evaluation of the past year.

Participation on the annual meeting will be subsidized by the section, but the members will pay for some of the costs. The annual meeting will be held in Stockholm on the 9-10th of may in 2020.
