### New campaign: Get a grip Sweden - Take Action!

*Did you know that a swedish law which demands corporations to respect human rights does not exist? This means that swedish corporations that are jeopardizing dangerous working conditions, pushdown salaries or silencing victims neither need to prevent or be held accountable if it occurs. Great Britain, France and the Netherlands have legislation on this matter and more legislation is in the decision-making process at the moment. Due to the circumstances Amnesty is now launching a new campaign for the making of such a law in Sweden.*

#### What do we want!

We demand that Sweden implements a new law that demands corporations to respect human rights in Sweden and abroad in all stages of the production process.

#### Why?

Sweden has since 2015 a framework for companies and human rights since 2015 and a legislation about sustainability reporting since 2016. The problem is that these have low demands on how corporations work with human rights and the law of sustainability reporting does not include any kind of sanctions for corporations that do not follow it.

Amnesty is annually examining (together with Fair Action) some sustainability reports from selected corporations. On the 1th of April this year a new examination will be released and create the basis for our coming working process. These examinations clearly illustrate that swedish corporations are not considering the consequences their business has on human rights to the extent needed. For example, we are seeing that well-known traveling corporations do not handle the issue about compulsory labour on the hotels hired by them. Additionally, shoe companies are avoiding to control if hazardous chemicals are used in production chains and swedish fashion corporations are hiding what factories clothes are produced in, which results in that organizations and work unions in the host countries cannot contact the persons incharge if workers are treated badly. Previous reports have highlighted that both children and adults working with the extraction of cobalt (that is used in phone-, car and computer batteries) are under dangerous working conditions in mines in the Democratic Republic of Congo.

All across the world activists that are protesting against corporations that are causing environmental degradation and are risking human lives and health are experiencing threats and attacks.

Many of the examined companies do not have a continuous work process that analyses, produces feedback and updates their business operation and human rights.

#### Our very simple demands:

- The long-term goal is a legislation that demands that corporations respects human rights in all of their production and supply chains in Sweden and abroad.
- The short term goal for the campaign is that the government starts an investigation for a possible legislation before the end of the year

#### Human rights due diligence?

What we demand is a legislation that grants that corporations carry out **human rights due diligence**. Human rights due diligence (HRDD) is a process in which a corporation carries out a consequence analysis of what operational effect will have or has on human rights. HRDD is according to the UN's guiding principles for companies and human rights an important tool for corporations to work with human rights.

#### The campaign is a cooperation

Amnesty is pushing this campaign together with 12 other organizations: Act Swedish Church, Afrikagrupperna, Concord, Diakonia, Fair Action, Fair Trade, Forum Syd, Oxfam, Save the Children, Swedwatch, The Swedish Society for Nature Conservation, UNICEF Sverige, We Effect. This means that we have a lot of good co-operations partners at a local level to contact for co-operations.

#### How do we put pressure on politicians?

To show politicians that we are a big group of people that demand new legislation, we will together with our co-operations partners collect signatures through a petition from both the public, corporations and organizations. These will later be handed over to a government representative

We will also have conversations with politicians and business representatives. For those who are interested in participating but did not participate in the Lobby training course in March, there will be opportunities to jump in on a local level. Please contact me if you are interested in this type of work.

#### Be creative!

In the task of collecting signatures be creative! We have shown our great capacity to be creative and get people engaged in previously campaigns on the issue. The goal is to collect a massive amount of signatures and how to do so is all up to you! The possible ways to get attention and get people to engage are limitless! Tips and guidelines can be found in the instructions will be sent to groups that sign up for the campaign.

#### When?

The campaign is fully starting on the 30th of March and the time for action till go on until the 31 of May. Although, the petition will be up on Amnesty.se from the 16th of March and we will need signatures from all of you!

### **As I see it...**

Have you heard about the Swedish company Lundin Petroleum? This company has been accused of contributing to non-comprehensible wrong-doings of human rights during the civil war that occurred in Sudan 1997-2003. Approximately 12 000 casualties have been estimated and 160 000 were forced to leave their homes in an area South Sudan where the company was operating. Lundin, on the other hand, is arguing that they have had a positive affect in the country and contributed to development and peace. Nevertheless, it does not seem like the company did think of the possible risk their operation could contribute within a conflict area, before they started their operation.

In my field, it is clear that companies or corporations, especially big corporations, have a big possibility to affect human rights in communities which they are operating in. If they wanted to. A couple of them do, often after getting criticised in media with reports of suspected child labour in a host country. Corporations act fast when they are accused of bribery, because there is a Swedish legislation, which means that the corporations are risking to get accused and possibly get convicted and forced to pay a fine.

When it comes to corporations' responsibility to respect human rights Sweden does NOT have good legislation even though we are proud and say that we are great at human rights. I, on the other hand, do not think that we are so great. We are lagging behind. Our government includes UN's guiding principles for corporations and human rights in their action plan from 2015. These principles are putting out the red carpet for legislation, but nothing happens. Maybe, Sweden is waiting for the EU to take action within this issue, instead of being a symbolic leader in the area of human rights.

All around Europe there are laws that states that corporations shall respect human rights, e.g. France, Netherlands and more countries are in the process of creating this type of legislation. Our Nordic neighbours Finland and Norway are in this process right now after vigorous campaigning from Amnesty and other civil

society organisations. Now it's our turn to push Sweden: We also need legislation that pushes corporations to take responsibility *for real*. And we need to do it now!

So what is needed for there to be a Swedish legislation? We need both knowledge and political will for a decision to be made. We are ready to educate! If it's about lack of political will, we will make more politicians demand a legislation by launching the broad-range campaign *Take Action!* Both civil society and other big corporations are backing us in this campaign. We want to see a decision from the government asap, before more negative effects occur for those affected by irresponsible corporations that just continue to walk the same path...

Prosecutors have been working with the Lundin Petroleum investigation for decades. We need a Swedish law that demands that Swedish companies respect human rights to avoid that Swedish corporations contribute to a negative impact on human rights.

### **Action week in april: Release Ahmadreza Djalali and eliminate the death penalty!**

Monday the 25th of April, 2016, the Swedish-Iranian doctor and researcher Ahmadreza Djalali was arrested as a suspect of espionage and association with Israel. He had been living in Sweden since 2009 with his family, but was in Iran to participate in a workshop about disaster medicine at the university of Tehran and Shiraz. In October 2017 he was sentenced to death in Iran.

Amnesty is annually releasing an international report about death penalty in the world. Around this time we get an update about progress and setback in the global fight to eliminate death penalty for good. It is also an occasion where we get the chance to highlight this issue in media: This year's report will be released on the 21 of April and we see this date as a perfect time to generally act on the issue by focusing and highlighting the case of Ahmadreza Djalali.

#### Our demands:

That Ahmadreza Djalali is released immediately and that his death penalty is repealed. There is no possibility for him to get a fair trial and therefore they should be released.

#### What shall we do?

Many of you have probably acted for Djalali's success before. Last autumn we wrote letters to him while he was in prison and collected 10 000 signatures via the web. This year, the thought is to make it inevitably clear for the ones responsible for his imprisonment that we have not forgotten Ahmadreza Djalali. By letter bombing the people in power in Iran (more information about the specific receivers of the letters will be uploaded on activist portalen and be stated in the next edition of Instas). We will be writing actual letters sent by post, best would be if they were made one by one and if there were MANY! Gather all, your most loved ones, acquaintances and strangers with their heart at the right place and urge them to write a letter, The more letters the better! Why not organize a correspondent marathon, a correspondent pub or cafe or the world longest correspondent table???

To get attention around the Djalali's case in Sweden - and to get more people to act, we are also writing letters to the editor in local media.

### When:

The action period is running from the 21 of April (when the report is released) to the 26th of April, due to the fact that Djalalis was put in prison on this particular day four years ago.

### Material:

There will be material to print in aktivistportalen and suggestions for the correspondence. Instructions in the shape of letter frameworks, letter to the editor tips and other types of material can be found in the cheat sheet that will be sent out registered groups. If you don't have a printer the secretariat can help you print the material.

Please, demand that the iranian government will repeal my death penalty and release me.*

*I'm looking forward to one day being able to return to a normal life and continue my research and everyday life. Thank you so much.*

### **ALSO HUMAN: EVERYONE SHOULD HAVE THE RIGHT TO HEALTHCARE!**

*Vulnerable EU- citizens in Sweden have the right to the same amount of health care as they get in their native country. Nevertheless, some countries are lacking universal healthcare, which leads to the most vulnerable citizens lacking the health insurance card that you are expected to show when you are seeking healthcare in a different country.*

We have heard testimonies from people that has sought emergency help and gotten a massive bill, women who has got denied help with contraceptive even though they have gone through repeated abortions and people that avoid seeking help due to the fear of being questioned or put in debt.

Amnesty wants vulnerable EU-citizens in Sweden to at least get care that cannot be deferred either they have an insurance card or not. This is the principle that applies to undocumented immigrants. This includes acute health care, maternal health service, health care for children and abortion and contraceptive counseling.

### How you can help!

Amnesty is planning a meeting with the health minister Lena Hallengren later this spring. The purpose of this meeting is to show the different possibilities that exist for this group to get access to health care in different parts

of the country. This is unacceptable for a country that respects human rights. To be able to illustrate this issue we need more information from different healthcare providers and politicians. We would love to see this issue get publicity in local media. Some of you have already got started, but we need more to help out with the following tasks:

- Ask questions to medical centers, emergency rooms and dentist offices.
- Call your region politicians and ask for a meeting.
- Write a letter to the editor about the result.

### **Urgent Action!**

#### **Young comedians in Myanmar are sentenced to death - Act Now!**

The satire group Peacock Generation is putting up shows with satire poetry, music and dance - "Thangyat" - which is a traditional artform in Myanmar. Six artists were arrested in April-May 2019 after a show in which the performers were wearing military uniforms and were criticizing Tatmadaw, Myanmar's military.

These six artists have been sentenced to prison for two or three years. Three out of them Kyye Myint, Saw Wai och Nay Myo Zin were on the 17th of February convicted to another six months on the ground of online defamation. All they did was to livestream their show on Facebook.

The artists have not committed any type of crime, they are prisoners of conscience and should be released immediately. To silence critics, activists and artists by putting them in prison for peaceful activism is unfortunately a common method used by the military in Myanmar. For this reason we need to act now! ### **Information from the board**

At the board meeting in february new ideas about how members should be included in the secretariat operation planning, next strategic period, planning of the secretariats annual meeting and policy for language usage was discussed.

At the annual meeting in 2019 new guidelines for how and when members should be involved in the secretariats operations planning was decided. At the february meeting, the board discussed a proposal based on the new strategy for activism and gives members the chance to influence the planning of the organisations development on two different levels. Firstly, on a strategic level in terms of operation of the overall goals and the framework for the secretariats priorities. Secondly, on an operational level which includes planning of the larger key activities, such as campaigns, courses and annual meetings. The board also emphasised the need of a cycle that illustrates the connection between the questions discussed internationally and the decisions made at the annual meeting Global Assembly, that also clarifies how and when members can participate in this type of planning. Questions will be further discussed during the meeting in March.

Parallel with these discussions is a larger member consultation regarding the next strategic period. The international movement will make a decision about the new common goals for all of Amnesty International at the Global Assembly this summer. After that the swedish section will design their specific goals within the framework of the common international goals. If you are interested in participating in this process, these opportunities will be held during fall 2020 and spring 2021.

During the annual meeting 2019 the board asked for an implementation plan including policy documents to be created on the issue of getting more participation through working material in english. At the board meeting in february a proposal regarding that the implementation plan and that swedish should be the languages used in external material. Material that has a longer life span can be translated to english and that when new material are produced a possible translation to english should be reviewed. The secretariat should also arrange meetings for student groups and youth groups continuously. The board stated that it's important to allocate reasonable costs for translation and its important to not only take certain groups into account, instead we should consider all members and potential members that will be in need of english translations. More detailed information about this implementation plan can be found on the member sites as support for the board meeting in february.
