The FIFA World Cup in Qatar - a party for EVERYONE?

In relation to the start of the European qualification matches on March 22, Amnesty has launched an international campaign about the World Cup in Qatar 2022. The campaign highlights the migrant workers situation in Qatar and it will run from March 2021 to the summer of 2023!

The situation in Qatar: 95% of Qatar's workforce are migrant workers. They are building the arenas, roads and subways, will work in the transport, hotel and restaurant industry and with security on site. Everyone who travels to Qatar during the World Cup will be taken care of by migrant workers during their stay. Despite the fact that Qatar has implemented several reforms to improve the situation, thousands of migrant workers are still being subjected to harassment and are still being exploited by their employers.

FIFA: During the first part of the campaign we will focus on FIFA. FIFA has a responsibility to take action when people who work in different World Cup-projects are being exposed to work-related violations. Therefore, FIFA has to use its influence to call for Qatar to protect all migrant workers!

Amnesty demands that FIFA:

- Makes sure that human rights are being respected in both the organization and the execution of the World Cup.
- Together with Qatar, ensures that all workers who have been injured in a World Cup-related project are compensated correctly.
- Uses its influence to demand that Qatar implements its reforms before the start of the World Cup, and that the implementation applies to all workers who are linked to the tournament.
- Publicly commits to include human rights criterias and a due diligence-process when selecting future host countries for the FIFA World Cup.

Take action!

The visits to the Swedish Migration Agency's detention centre is a very important part of Amnesty's work for the rights of refugees and migrants. Our visitors meet people who have been deprived of their liberty in anticipation of their deportation from Sweden. The visitors contribute with a compassionate support and make sure that the detainee's fundamental human rights are being respected. As a detention visitor, you are a part of a group who, in addition to carrying out the visits together, is in regular contact with the refugee and migration team at the secretariat. The groups and the team at the secretariat also meet a few times a year to learn from and share knowledge with each other.

We are now looking for more people who want to be a part of a group in Gothenburg, Gävle, Märsta and Åstorp. We would also like to start new groups in Flen and Ljungbyhed. To become a detention visitor, you need to participate in a basic education on Amnesty's work on refugees and migrants. Thereafter, you apply for the role of a visitor and join a group.

In October 2018, the Saudi Arabian journalist and government critic Jamal Khashoggi was assassinated at the Saudi Arabian consulate in Istanbul. The documentary "The Dissident", which follows the Khashoggi case, has now had its release. On April 15 at 6-7 PM, Amnesty Norway will arrange a digital panel discussion on how Saudi Arabia operates abroad and how they persecute and monitor human rights defenders, even outside of the country's borders. The board informs

- At an international level, we are currently designing the organization's global work strategy, which will direct all of our work. The suggested areas of focus for the upcoming years are freedom of expression, freedom of association, equality and discrimination. The strategy proposes that 80 percent of our work should focus on these areas. The strategy will apply from 2022-2030 and will be decided this summer.
- The Swedish section has performed relatively well in 2020, despite the covid-19 restrictions. The board can state that the pandemic has affected us the work has become a little less extensive and it has been difficult to recruit members through face2face. Although, the board has a good plan for how to increase our income for the future.
- Amnesty has been mentioned a lot in the media lately and it has unfortunately not always been positive. We, together with the secretariat, are doing our best to continue the work of making Amnesty an inclusive workplace and organization.
 Fortunately, the media have also paid attention to our regular work, like that with the situations in Belarus and Myanmar.
- The Annual General Meeting:
 - The meeting will be held online this year.
 - We have only received two motions from groups and members this year.
 Since both motions raise important issues, we hope that the motions will start interesting discussions. To encourage this, the participants of the Annual General Meeting will be able to participate in a workshop where they can discuss the motion on how we can get better at working with urgent actions.
 - The board also has its own proposals. Among other things, we propose that the members who are employed by the secretariat should not have the right to vote at the Annual General Meeting, as this may give rise to conflict of interest situations and employees have the opportunity to influence the organization in other ways.
 - The board will also arrange a workshop on how we can strengthen the democracy in the organization. During the Annual General Meeting of 2020, only 100 people participated. As this raises the question of whether these participants are representing the organization in a good way and what we can do to increase the influence of activists and members.

About not being interviewed, or denied an interview in Amnesty Press

Dear members.

This concerns the latest issue of Amnesty Press and the part called "The Crisis on Amnesty part 2", in which it is claimed that I did not come forward in an interview. I have had an email conversation with Amnesty Press, where I explained that I believe that I have been interviewed and have not denied participating in an interview. I did send my answers to the interview questions regarding the General Secretary's departure. Therefore, I do not agree that I did not come forward in an interview.

The answers I had sent were exactly the same as the answers I had given to other parts of the media, and at times I did also answer these questions through emails and sometimes even through text messages. I have nothing more to add about the previous General Secretary's departure. Moreover, after my email conversation with Amnesty Press, I now understand that they did not consider the way I answered the questions as an interview. I also understand their perspective that it is not journalism when someone sends their answers as I did. Although, my point is that even if we had spoken over the phone, my answers would still have been exactly the same. In my world, I was answering interview questions and was therefore interviewed.
